



# Who are Torbay and South Devon NHS Foundation Trust?

We are a medium sized Hospital providing Acute Clinical services - A&E and ICU Emergency Care, Maternity services and Elective procedures (Planned operations e.g. Hip replacement).

We also provide Community services in our Community Hospitals and Wellbeing Centres, as well as Adult Social Care.

We were the first Trust to combine all these services 6 years ago.

### Snapshot of the organisation: -

- 1 x main acute hospital in Torbay with 546 beds
- 5 x community hospitals
- The ability to manage
  - over 500,00 face-to-face contacts with patients in their homes
  - 75,000 ED attendances
  - 53,000 inpatient admissions
  - 546 beds
  - 586,000 outpatient attendances (face-to-face / virtual / telephone)
  - Technology enabled care services (TECS) / Remote monitoring
- Torbay 0-19 service
  - School Nursing, Health Visiting and charitable services from Children's Society and Action for Children for 0-19
    in Torbay. TSDFT are sub-contracted by Torbay Council for this service
- Child and Family Health Devon (CFHD)
- This is an alliance of local NHS Providers led by TSDFT in partnership with: Devon Partnership Trust, Royal Devon and Exeter NHS Foundation Trust, Northern Devon NHS Trust and Livewell SouthWest

#### There are three core elements of our BBF Programme:

- Workforce empowering our staff to transform services with new models of care through smarter and better application of digital.
- Estates bringing our estate into the 21st century such that they are able to take advantage of the digital age.
- Digital taking a digital first approach. Realising our need for a connected health and care solution for the ICO and across the ICS. The Electronic Patient Record (EPR) is the foundation of our solution.

The funding for this is around £350m

# How Torbay and South Devon NHS Foundation Trust use Supply Devon

- So far we have only engaged with Supply Devon for one project and this is ongoing
- The project is for Warehousing Space in Torbay
- This identified a number of potential providers and facilities, these were reviewed and one was deemed suitable for our requirements
- Our requirement was a mixed use of secure storage: -
  - Fast and slow-moving PPE inventory pallets
  - Slow moving Clinical Records Paper folders 2.5m high shelving
  - Emergency Medical Equipment, Beds, ventilators etc.

We plan to use the system mainly for non-clinical goods and services

# Who will be interested and what will it change / support?

- Different approaches to contracting
- Engaging with those responsible for: -

### What did we hope to achieve?

- Learning not repeating the past
- We had an expensive model 2005
- Create a framework of providers and standardised
- Self-optimising
- Make the documents available as to what we put out into the market
- Get the voices of the providers as part of this
- Note that the pre-work was there with the Care Collaborative
- Develop equal, 2-way Relationships

#### **Process**

- A project team was formed July 2019 comprising of Council and CCG commissioners, Trust and Council Procurement, ICO management, ICO operations (inc Arranging Support, Quality Assurance, Social Work, Brokerage, Finance & Benefits) and ICO Finance.
- Governance was provided by the Living Well @ Home Board and Executive Board.
- The project team met every two weeks and was supported by three subgroups finance, specification (including KPI's) and procurement.
- The Services to which this Procurement relates fall within Schedule 3 of the Public Contracts Regulations 2015 (the 'Regulations'). As such, the procurement of the Services is being run as a bespoke, single stage application process akin to a Framework procedure.
- Price had been set at £20.48 per hour (from 1<sup>st</sup> April 2020).
- All applications were be evaluated in three (3) parts:
- Selection Questionnaire (SQ). The prospective Providers must pass this national standard document and must agree to the hourly rate;
- Award Criteria Questionnaire (the written response) weighted at 50%
- Facilitated discussion weighted at 50%.
- The prospective Providers must achieve an overall score equal to or greater than 50% to be awarded a contract.
- The procurement process also allows for further windows of opportunities to be opened.

### Key points

- Handover / start up in Covid April 2020
- Reduction in outstanding hours single figures from 100's of hours not filled
- Size of specification reduced from 53-35 pages
- Flexibility for evolution of the contract and delivery during the 5 years including payment / compensation mechanisms
- Care Collaborative Director of Nursing if you're not in you're not in No guaranteed work
- Firmness of purpose not about being wishy-washy or ambiguous messages
- Review of Pl.s / KPl.s what matters and providers testing themselves
- Intellectually / emotionally signed up to them not just physically on the contract
- Shaped the PI set with the providers what's in / what's out / What's the value in the PI What's In It For Me? What's In It For someone else?
- Time to discuss, explain, explore

## What is Social Value?

#### Cabinet Office

"Social Value refers to wider financial and non-financial impacts of projects and programmes including the wellbeing of individuals, communities, social capital and the environment"

# Public Services (Social Value) Act 2012

"An Act to require public authorities to have regard to economic, social and environmental wellbeing in connection with public services contracts and for connected purposes"

#### Social Enterprise UK

"the additional benefit to the community from a commissioning/procurement process over and above the direct purchasing of goods, services and outcomes".

## Social procurement

- PLUS generation of Social Outcomes



## What does Social Value look like? Example – New Job

- On the one hand....
  - Happy family
  - Good education
  - Good CV
  - No criminal record

=Salary


- On the other hand
  - Troubled family
  - Left school at 16 no GCSE's
  - Petty criminal record, likely to get worse

= Salary + Social Value

A value can be attributed to this

## What does this mean for suppliers?

In terms of evaluating and awarding a contract it means that as well as quality & price – added Social value can also be scored as part of the evaluation and award criteria.



## Social Value Policy at Torbay Council

- Minimum of 10% of overall scoring will allocated to Social Value in all procurements over the value of £50,000 (3% quantitative and 7% qualitative).
- Focus on the quality of Social Value offers we receive and are implemented.
- Some procurements may have some social value commitments being given an additional weighting – for example where contracts are identified at high risk to Modern Slavery risks or have potential negative impacts on the environment

## Social Value Measurement

- The National Social Value Taskforce was formed to develop a national measurement solution for Social Value.
- They developed the National (TOMs) Social Value Measurement Framework
  - Themes
  - Outcomes
  - Measures
  - Units
  - Value

## Torbay Council Social Value Framework

- We are committed to a performance and evidence based approach to Social Value.
- We have mapped our Council priorities to the National TOMs framework to signpost suppliers to Social Value contributions that will make the most difference to Torbay.
- In the future all procurements will include either the 'light set' or 'master set' of the Torbay Council Social Value Framework.
- For larger procurements (over the value of £250,000) we will be using the Social Value Portal for both the procurement and contract management of Social Value.

## **Key Points**

- Social Value is not compulsory but will be included in the overall scoring of submissions.
- Any Social Value offers made will form part of your contract and be performance managed in the same way.
- Make sure any Social Value offers are proportionate and relevant to the business and specific contract.
- Social Value offers can only directly relate to the contract being procured.
- Core requirements of the contract cannot be counted as social value.
- You cannot double count Social Value.
- They must be measurable & quantifiable.
- Focus on local delivery.
- Do provide good descriptions and any relevant evidence of how you will deliver Social Value.
