- OCNLR Level 1 Award in Skills for Professions in Construction and Engineering
- L1 Award in Health and Safety in a Construction Environment (needed for the CSCS labours card) waiting for card
- OCN Entry level 3 Certificate in Professional Horticulture Skills
- Level 2 Function Skills in English

Adam will be sorely missed both for his dedication to work and the horticultural site and for his gentle personal attributes. Adam wishes to continue volunteering for as long as is possible. Any employer will be lucky to have such a dedicated and adaptable employee. Adam will go far in life and the team at Eat That Frog wish him every success.

TDA Support

The support provided from TDA has been helpful and consistent. The process to set up an initial Kickstart opportunity was clear and once approved the opportunities went live quickly. We successfully recruited to most of the opportunities but due to low applications for some of the Kickstart

opportunities we decided to not continue with those roles.

Outcome:

Adam has expressed an interest in continuing to work within the Horticultural Industry across a variety of different occupations such as nurseryman, greenkeeper, or landscape gardener. To this end he has applied for several such job vacancies, one of which is as an apprentice with Exeter University for their grounds team, in which he would be able to gain a full Level 2 Horticultural qualification.

About the project



The Kickstart Scheme is a government initiative to create high quality six-month work placements for people aged 16 to 24. Young people are more likely to have been furloughed, with many working in sectors disproportionately hit by the COVID-19 pandemic.

TDA is acting as a gateway organisation for the Kickstart Scheme in Torbay, supporting businesses with their applications, employability support and liaison with the Department of Work and Pensions.

Job Placements created with Kickstart funding must be new jobs and cannot replace existing or planned vacancies.
